1. Meeting Opening

- Sarah moved, Nikki seconded, and it was carried, to approve the minutes for the OEA Board of Directors meeting of May 15 2025.

2. President's Report

The President advised the BOD that EC is developing programs whereby a certain percentage of the EC Eventing levies will be available to organizers of sanctioned horse trials for approved expenditures. These Organizers will be able to apply through the OEA, under certain spending baskets such as "jump building" Safety issues and Officials, for example. Details of the program will be released in the coming weeks. It will apply equally to all the PHTAs across Canada. The BOD will have an opportunity to develop criteria by which to assess applications that come in from Ontario's organizers.

3. Treasurer Report

- The Treasurer confirmed that the applicants for the Officials' Bursary have been reimbursed.
- One director asked for additional details on the budget. The Treasurer offered to
 provide a breakdown and walk the director through the accounting to help clarify the
 budget as necessary.
- The Treasurer reported that the budget will be revised based on what has been approved and that the OEA is currently running a deficit of about \$20,000 a year, which means it is using its accumulated cash.

Bernadette put forward a motion to approve the 2025 budget, Doug seconded. All voted yes and the budget was approved.
